

# BOUNCEFITBODY

## TERMS AND CONDITIONS – BODYWORKSHOP

BY SECURING A SPACE & CONFIRMING PAYMENT, IT IS AGREED THAT THE PARTICIPANT UNDERSTANDS AND ACCEPTS THE FOLLOWING:

1. Throughout this document We shall refer to Bouncefitbody Ltd., respective management, employees, representatives, successors and assigns as “We,” “Us,” or “Our”
2. The person taking part in, or present at, the event (“Participant,” “You”) hereby agrees that they are physically fit and without any medical condition that has not already been discussed or approved by a Doctor or ((BOUNCE))™ Management in writing in advance.
3. Any past or present bodily ailments or concerns must be advised and reiterated both at the time of booking the event and to the instructor of the particular event before it begins.
4. The Participant agrees that there are risks of injury and to health associated with exercising and agrees to participate in the event knowing this You must make yourself aware of all safety instructions and warnings, do not exercise beyond Your own abilities. If during the event the Participant and/or guardian become unwell You should immediately stop taking part in the event and notify Us.
5. The Participant understands that this session is not open to those under 16 years of age.
6. ((BOUNCE))™ is specifically designed for use with equipment supplied by Bouncefitbody Ltd. The Participant acknowledges they shall not be permitted to use any other rebounding product or equipment during our event. We shall take all reasonable steps to check and maintain the equipment We supply, however if You have any concerns over the safety of any of the equipment, We provide You must notify Us immediately and stop using the equipment.
7. The Participant understands there is strobe/stage lighting in operation at events and the use of additional special effects during the day.
8. The Participant understands that food is provided by 3 rd parties, should you have any severe dietary allergies You must notify Us immediately.
9. The Participant understands that the application of any cosmetic product is optional and should not be undertaken if there are any concerns on the products used.

11. Our liability to compensate You for any loss or damage (in the case of loss or damage other than death or personal injury) is limited to a reasonable amount having regard to such factors as whether the damage was due to a negligent act or omission by Us. Our liability for death or personal injury is also subject to certain limitations.

We may compensate You for any loss or damage You may suffer if We fail to carry out duties imposed on Us by law (including if We cause Your death, or personal injury to You by Our negligence) unless that failure is attributable to:

- a) Your own fault (including your failure to follow Our reasonable instructions or comply with these terms);
- b) a third party unconnected with the provision of Services under this contract; or
- c) events which We could not have foreseen or prevented even if We had taken all reasonable care.

12. ((BOUNCE))™ reserves the right to amend the event schedule and will offer a refund/alternate session as necessary, or, may politely deny participation based on any foreseeable health concerns or conflict of interest.

13. ((BOUNCE))™ reserves the right to cancel the event at any point once it has begun should the Instructor consider any Participant injured, unwell, not behaving in an acceptable manner or not following reasonable instruction.

14. ((BOUNCE))™ events must be paid for in advance via the online booking system.

b) We have the right to refuse entry to any participant not on the bookings list.
