Terms of Conditions and Waiver of Liability

Thank you for joining Petits Robins Stay and Play and our community of outdoor lovers.

Understanding and Acceptance of Risks

I understand that taking part in activities planned by Petits Robins' team involves natural and unavoidable risks, even when appropriate safety measures and supervision are in place. These activities may expose participants to hazards associated with outdoor play, exploration, and physical activity. Possible injuries may range from minor cuts, grazes, bumps, bruises, and strains to more serious injuries in rare circumstances.

I recognise that risks may arise from the environment, weather conditions, natural features, equipment, the actions of other participants, or unforeseen events. By allowing my child to participate, I accept these risks and confirm that I am satisfied that my child is able to take part in the activities offered. I understand that it is my responsibility to consider my child's abilities, needs, and limitations when deciding whether they should participate in any activity under my supervision.



Concent to receive First Aid

I understand that taking part in activities may involve a risk of injury to the participant. I acknowledge that a qualified first aider will be available during the session and give permission for appropriate first aid or emergency medical assistance to be provided if required.

I understand that it is my responsibility to disclose any relevant medical conditions, allergies, medications, additional needs, or other important health information relating to both the child and attending adult by completing the medical information form accurately and fully. I agree to inform staff of any changes to this information as soon as possible.

Appropriate Clothing

Il confirm that I am responsible for ensuring that both my child and any accompanying adult are suitably dressed for all activities, and I acknowledge that I have been informed of the recommended clothing.

Severe or Unsafe Weather Conditions

Due to the outdoor nature and location of our sessions, weather conditions may affect participants safety. I acknowledge that Petits Robins reserves the right to cancel and postpone the session in the event of unsuitable weather conditions, or other unforeseen circumstances.

Personal Belongings Responsibility

I acknowledge that I am solely responsible for my personal belongings before, during, and after each session with Petits Robins.

Parental Supervision

Petits Robins staff members are not responsible for supervising your child. I understand that I am required to supervise my child's activities at all times throughout the programme.



Waiver of Liability

I hereby release, waive, and discharge Petits Robins from any and all claims, demands, liabilities, and obligations of any nature arising directly or indirectly from participation in the outdoor activity. This includes, without limitation, claims arising from negligence, breach of contract, or breach of statutory or other duties. I acknowledge that this waiver extends to all known and unknown, foreseen and unforeseen injuries, losses, damages, or consequences of any kind.

This release also applies to Petits Robins, the event organisers, partners, members of staffs and volunteers. I further agree that this waiver and indemnity shall remain in effect indefinitely and shall be binding upon my heirs, executors, personal representatives, and assigns.

I confirm that I have read and understood this waiver of liability, assumption of risk, and indemnity agreement. I understand that by signing or initialling this document, I am agreeing to release Petits Robins from any liability related to my child's participation in the programme.
