

RELEASE, WAIVER, AND INDEMNITY AND MEDIA RELEASE

I waive and forever release any and all rights and claims for any damages and liabilities of any kind arising out of my, or my child's participation at Little Sensory Co. against all persons, entities and agencies, including but not limited to Little Sensory Co. and Little Sensory Co.'s owners, affiliates, successors, assigns, employees, and agents, even if liability may arise out of negligence or carelessness on the part of Little Sensory Co. or its owners, affiliates, successors, assigns, employees, and agents. Further, I release Little Sensory Co. from any claims or damages that may be sustained by a minor in my care or custody accompanying while at Little Sensory Co.
2. I hereby agree to indemnify, defend, and hold Little Sensory Co. harmless from and against any and all claims, liabilities, losses and damages, costs, expenses (including attorney's fees) judgments and penalties arising out of my participation.
3. I assume the risk of all bodily injuries, including permanent disability, paralysis and death, resulting from my participation, as well as damage to and loss of my property, including loss of use thereof and any other indirect or consequential damages, resulting directly or indirectly, wholly or in part, from my participation.
