

Gasshuku 2022: Assumption of Risk, Waiver of Liability, Medical Authorization, Media Release

I am entering into the following Release and Waiver Agreement with Emerald City Karate, Family Karate Center, Yakima School of karate and all of their affiliated instructors associated with this martial arts training camp hereby referred to as Gasshuku. I understand that I am signing this agreement in consideration for and as a requirement of participating in the Gasshuku.

(1) Assumption of Risk

I understand the inherent risks involved in participation in martial arts including serious personal injury or even death. I know that martial arts are a contact endeavor, and I understand that I am responsible to follow the guidance of doctors when evaluating my child's or my own physical condition and ability to participate in any and all programs and activities related to Gasshuku. I also understand the risks that Covid 19 presents and will hold harmless Emerald City Karate, Family Karate Center, and Yakima School of karate in the unlikely case that my child or myself develops any sickness after attending Gasshuku.

(2) Waiver of Liability

In consideration for me or my child's participation I hereby, for myself and my child and our respective successors, heirs or assignees and legal representatives, I do now and forever, fully and finally, release and discharge and waive Emerald City Karate, Family Karate Center, and Yakima School of Karate, their employees, volunteers, interns and agents from any and all claims, demands, damages, expenses, costs, actions or causes of actions known or unknown, past, present or future for any personal injuries including bodily injury or death which are alleged to have arisen out of or resulted from participation in any and all activities, including but not limited to, martial arts classes training, exercises, drills, all the above named individuals, entities and corporations.

(3) Medical Authorization

In the event of an accident or emergency, I hereby authorize myself or my child to be transported to a hospital for medical treatment and I hold Emerald City Karate, Family Karate Center, Yakima School of Karate, and their representatives harmless in the execution of such. Additionally, I hereby agree to individually provide for all medical expenses which may be incurred by myself or my child as a result of any injury sustained while participating at Gasshuku.

(4) Media Release

I understand that individual or group photos, videos and audio recordings may be taken from time to time and in consideration for myself or my child's participation. I hereby authorize Gasshuku instructors, participants, and personnel to take, use and publish photographs, video and audio records of myself or my child for education, public relations, marketing and purposes related to Emerald City Karate, Family Karate Center, and Yakima School of Karate.

I have read and understand (1) Assumption of Risk, (2) Waiver of Liability, (3) Medical Authorization, and (4) Media Release carefully and have fully understood the content and consequences of this agreement. I freely and voluntarily affix my name in agreement.
