

# Little Seashells Activity Cabin

## *Make a Mess with Little Seashells*

### **Terms, Conditions & Policies**

These Terms and Conditions apply to all sessions, parties and events hosted by **Make a Mess with Little Seashells at the Little Seashells Activity Cabin**. By attending a session, class or party you agree to the following conditions.

## **1. Supervision of Children**

Parents and carers remain solely responsible for the supervision, control, care and safety of the children in their care at all times while attending Little Seashells sessions. Children must not be left unattended. Adults must accompany children when entering or leaving the cabin, garden pathways, decking and surrounding areas.

## **2. Behaviour and Safety**

Little Seashells reserves the right to ask any adult or child to leave a session if behaviour is unsafe or disruptive. Attending adults are responsible for ensuring their child behaves in a way that does not cause harm or distress to others.

## **3. Personal Property**

Little Seashells cannot accept responsibility for loss, theft or damage to personal belongings while attending sessions. Please avoid bringing valuable items.

## **4. Clothing for Messy Play**

Messy play involves paint and sensory materials. Children should wear suitable clothing. While washable materials are used where possible, Little Seashells cannot be held responsible for staining or damage to clothing.

## **5. Illness Policy**

Please do not attend sessions if your child is unwell. Children who have experienced sickness or diarrhoea must not attend for 48 hours after symptoms have stopped. If a child appears unwell, families may be asked to leave to protect others.

## **6. Allergies and Food Materials**

Parents must inform Little Seashells of any allergies at the time of booking. Parents remain responsible for ensuring children avoid materials that may trigger allergies. Food packaging information can be provided on request.

## **7. Use of Messy Play Materials**

Every effort is made to use non-toxic or taste-safe materials where possible. However, materials provided during sessions are not intended to be consumed. Parents must supervise children closely as some materials may present choking hazards.

## **8. Children's Creations**

Please take home any artwork or creations at the end of the session. Items left behind may be discarded.

## **9. Attendance and Refunds**

Due to preparation and limited spaces, refunds cannot be issued for non-attendance. Transfers may be offered at the discretion of Little Seashells where possible.

## **10. Cabin and Property Access**

Sessions take place within the Little Seashells Activity Cabin and surrounding garden area. Parents must supervise children while using paths, decking and entry areas. Little Seashells cannot accept liability for accidents while entering or leaving the property.

## **11. Photography**

Photos may occasionally be taken for promotional purposes. Permission will always be requested before images are used on social media or marketing materials.

## **12. Insurance**

Make a Mess with Little Seashells holds Public Liability Insurance.

## **13. Agreement**

By attending a Little Seashells session, class or party you confirm that you have read and agree to these Terms and Conditions.
