As an attendee in Microsoft Teams Live Events, you will not be visible or audible to other attendees or the Commission but you can participate in the moderated Q&A throughout the webinar.

Joining Instructions

The simplest way to join the webinar is via the web from your desktop. You can also join via the Microsoft Teams app on either your desktop or mobile device. Please note, if joining via a mobile device, you will only be able to join via the Microsoft Teams app but you will not need a Microsoft account.

Option 1 – Watch on the web

Please note, this option is not possible from a mobile device and you will need to follow the instructions below for joining via a mobile device (<u>see Option 3</u>).

Firstly, click on the required link for the webinar. The link is provided in the Bookwhen booking confirmation email as well as being sent by the Charity Commission via email to attendees in advance of the webinar.

Once you have clicked the required webinar link, the following window will appear and you need to select 'Watch on the web instead':



The following window will then appear:

Option 2 – Watch in the Microsoft Teams App via desktop

It is recommended that you <u>download the Microsoft Teams app</u> prior to joining the webinar.

Once you have downloaded the app, click on the required link for the webinar. The link is provided in the Bookwhen booking confirmation email as well as being sent by the Charity Commission via email to attendees in advance of the webinar.

After downloading the app and clicking the required webinar link, you will see the following window and should click 'Launch it now':

Option 3 – Watch in the Microsoft Teams App via a mobile device

If you are watching via a mobile device, you must have the Microsoft Teams app but you will not need a Microsoft account. It is recommended that you <u>download the</u> <u>Microsoft Teams app</u> prior to joining the webinar.

Once you have downloaded the app, click on the required link for the webinar. The link is provided in the Bookwhen booking confirmation email as well as being sent by the Charity Commission via email to attendees in advance of the webinar.

After downloading the app and clicking the required webinar link, you will see the following window and should click '*Open it*' and then, in the following window, click '*Join meeting*' to access the webinar without signing into an account:



If you have a Microsoft account though, you can also sign in to access the webinar.

If you do not sign in, Microsoft will then ask you to provide a name. The Commission does not require you to provide your personal details here and you are welcome to simply type 'Anonymous' – as demonstrated here.

Then click 'Join meeting'.
